

General Promotion Terms and Conditions

- 1. These terms and conditions ("General Terms") apply to all promotions, competitions and offers listed below (collectively, "Promotion").
- 2. In these General Terms, Glass Group means Glass Group Limited, at times referred to "we" or "us".
- 3. All Promotions are only open people aged at least 18 years.
